

- Sub Area Plans. Sub Area Community plans are a component of the SA Tomorrow Plan. This structure for the city was designed to facilitate working with neighborhoods more efficiently. RRN is part of The Near North Community Plan. Neighborhood discussions about this plan are anticipated to start later in the fall of this year and it usually takes approximately two years to complete. The City of San Antonio (COSA)

- Presently the Committee is working with the owners of the empty lot at 3314 N. St.
- Mary's. This lot is zoned as Neighborhood Commercial (NC) and the owner is requesting a conditional use (CD) for a parking lot. A property zoned NC can't be used for a parking lot unless the CD is obtained. Also, this property is in a RIO-1 overlay with its own special requirements.
- The case was presented at the last zoning meeting but was granted a continuance. The owners have worked with the Development services to redraw their site plan and address safety conditions. On Friday check the saspeakup site to see if they are scheduled for the next zoning session on September 19 th .
